2	Eligibility	<p>i) The retired Officers of PBGB and other Commercial Banks in Scale – II and above can apply for empanelment. (Hereafter will be termed as applicant).</p> <p>ii) Age of the applicant as on date of application should not be more than 70 years.</p> <p>iii) Applicant should have unblemished track record and have minimum 20 years of continuous service in Bank as Officer.</p> <p>iv) Applicant should have good exposure to credit dispensation.</p> <p>v) Applicant should have adequate expertise and working knowledge in computerized environment and should be able to handle computers independently.</p> <p>vi) Applicant should have capability to operate Finacle System independently coupled with requisite investigation/inspection aptitude and analytical ability.</p> <p>vii) Applicants having working experience in Inspection Department will be given preference.</p>
