TO ALL PENSIONERS AND FAMILY PENSIONERS OF PACHIM BANGA GRAMIN BANK

Sub: Submission of Life Certificate along with Acceptance/Non-Acceptance of Commercial Employment Certificate and Certificate of Non-Remarriage/Re-Marriage of Pensioners & Family Pensioners.

In view of the Circular No. PBGB/HO/PAD/104/2022 -23 dated 13/10/2022 it is also required for the pensioners to submit certificate of non-employment/re-employment and certificate of re-marriage/marriage.

For this it is advised that along with Life Certificate in Form No. - 6 as per Paschim Banga Gramin Bank (Employees') Pension Regulations, 2018, **Form-7 for Acceptance/ Non-acceptance of Commercial Employment and Form-8 CERTIFICATE OF NON-REMARRIAGE / NON-MARRIAGE** are to be submitted by the Pensioners & Family Pensioners once in a year in November to the pension drawing branch which **will be duly verified by either Branch Manager / any other officer of the concerned branch or by a Gazette Officer**. With this circular we are also attaching a consolidated form of Form -6, 7 and 8. Pensioners either can submit the duly filled Forms-6, 7 and 8 individually or submit duly filled consolidated form.

The branch will in turn submit the same to the respective Regional Office and the Regional Office will submit the Life Certificate to Head Office, Pension Cell well before processing of pension payment from the month of November every year. In the event of non-availability of Life Certificate, Pension cannot be processed in due course.

With this circular we are also attaching a consolidated form of Form -6, 7 and 8. Pensioners either can submit the duly filled Forms-6, 7 and 8 individually or submit duly filled consolidated form.
