TO ALL PENSIONERS AND FAMILY PENSIONERS/BRANCHES/OFFICES OF PACHIM BANGA GRAMIN BANK

Sub: Submission of Life Certificate of Pensioners & Family Pensioners.

As per Paschim Banga Gramin Bank (Employees') Pension Regulations, 2018 as amended, pensioners and family pensioners are required to submit life certificate along with other declaration once in a year in November to the pension drawing branch which **will be duly verified by either Branch Manager / any other officer of the concerned branch or by a Gazette Officer.** In the event of non-availability of Life Certificate, Pension cannot be processed in due course.

It is further advised that photocopy of recent bank statement where EPFO PENSION is received (if applicable) duly signed by the Pensioner/Family Pensioner must be submitted along with life Certificate.

Accordingly, all pensioners and family pensioners must submit duly filled Life Certificate only in the format as attached from 28th October, 2024 onward till 30th November, 2024 in their concerned pension paying branch.

Branch managers will preserve the Life certificate in their branch and will share the details, legible photo or scanned copy of life certificate and EPS 95 pension in the link as shared below.
