Sub: Submission of declaration regarding drawing of pension from EPFO under EPS-1995.

After issuance of order by Hon. Supreme Court dated 25.04.2018 followed by direction from NABARD, Board of Directors of Paschim Banga Gramin Bank accorded approval for implementation of Paschim Banga Gramin Bank (Employees') Pension Regulation, 2018 in Paschim Banga Gramin Bank.

Though the PBGB pension regulation, 2018 came into effect from April 2018, many staff members have claimed pension from EPFO as per EPS 1995 act. Now to arrive at the actual pension payment being made to the retired staff members retired after 31-03-2020, we have decided to include one **AFFIDAVIT – CUM – INDEMNITY BOND** for settlement of pension amount.

1. For those who will retire from bank on and after 31-01-2023 are required to submit the attached **AFFIDAVIT – CUM – INDEMNITY BOND** on NJ stamp paper of Rupees 100 along with their Paschim Banga Gramin Bank pension application form.
2. For those who have retired from bank after 01-04-2020 and are not drawing any pension from EPFO they will submit the attached **AFFIDAVIT – CUM – INDEMNITY BOND** to their respective pension paying branch by 20-02-2023.
3. We are attaching a list of pensioners as per Annexure-I for whom such declaration is not required as we have already received their pension contribution from EPFO.

The branch will forward the **AFFIDAVIT – CUM – INDEMNITY BOND** received from pensioners to the respective ROs which in turn should reach Head Office-PAD by 27-02-2023.
