

TENDER NOTICE FOR HIRING OF VEHICLE SERVICES

31/07/2024

Sealed tenders are invited for hiring of vehicles as per the terms and conditions. Tenderer may be Individual/sole proprietor /partnership firm/ company.

The period of the contract will be for an initial period of two years from the day when the letter of commencement is issued in this regard, which shall be treated for all practical purposes as the date of the commencement of the contract.

General conditions:

1. There should be a first aid box, dustbin, GPS navigation system and air freshener spray in the vehicle.
2. Period of Contract shall be two (2) years from the date of acceptance. However, the Bank may terminate the contract at any point in time by serving one month's notice in advance.
3. Fuel type -Diesel, petrol and CNG Gas kits are allowed as fuel in any vehicles as per govt. norms.
4. In the case of electric vehicles, the contractor should make his own arrangements for charging the vehicle at his cost.
5. The driver should be well conversant about West Bengal and other routes and must carry the mobile phone with him for which no separate payment shall be made by Paschim Banga Gramin Bank. The driver should come on duty in uniform.



6. The agency/individual should abide by all statutory requirements for running the vehicle on contract and Paschim Banga Gramin Bank will in no way be liable towards taxes, fees, penalties cost of fuel, and salary to drivers, maintenance or any other charges payable except the contract price, parking charges and toll tax, if any.
7. The vehicle should have the necessary permits from the transport Dept. /Authority. Paschim Banga Gramin Bank will not be responsible for any challan, loss, damage and accident to the vehicle or any other vehicle or injury to anybody.
8. The vehicle on hire shall be available, including Saturdays, Sundays and public holidays.
9. Duty hours: 12 hours (preferably from 09:00am to 09:00pm) Overtime will be paid @Rs. 100.00 per hour duly certified by concerned Bank official.
10. The Contractor should have enough resources to repair their cars in minimum possible time. When required, they should be able to substitute/replace or arrange extra vehicles at very short notice on their own. In case the vehicle is found not to be in working condition, it shall be returned for immediate replacement. In case no replacement is provided on time, this office would have the right to hire a vehicle from the market and the additional cost incurred by this office will be borne by the contractor.
11. The AC vehicles should have functional AC as well as a heating system.
12. Contractor shall comply with all statutory Acts, labour laws/regulations/motor vehicle Act etc.
13. All legal obligations which include insurance, pollution control, road tax & other compliances shall be complied with the contractor & Paschim Banga Gramin Bank will not take any responsibility in this regard.
14. The vehicle should have comprehensive insurance for the vehicle, driver and passengers etc. to cover the risk during the contract period. In case of any accident, all the claims arising out of it shall be met by the contractor and no claim whatsoever shall be borne by Paschim Banga Gramin Bank. **A copy of the current insurance policy should be submitted.**
15. In case of any dispute, the decision of the Regional Manager, Howrah Region, Paschim Banga Gramin Bank shall be final and binding.
16. The contractor shall not engage any sub-contractor or transfer the contract to any other person.
17. It is obligatory for the contractor that drivers are paid at least minimum wages according to minimum wages fixed by the govt. of India from time to time.
18. Paschim Banga Gramin Bank shall not be responsible for any accidents or other legal issues associated with the hired vehicle, and the service provider should furnish an affidavit prior to signing the agreement.
19. The Service Provider must abide by all rules, regulations, and guidelines in force in the operating States/UTs regarding running a transport agency.
20. In case of any vehicle breakdown on duty, the service provider shall arrange for another vehicle. In such a case, mileage from garage to the point of breakdown would not be paid.



21. A daily record indicating the time and journey of the vehicle shall be maintained in a log- book which should be submitted to the officer concerned of this Office for scrutiny & payment of the bills.

22. The service provider will provide a maximum of 2000KMS. run on monthly basis and journey beyond the limit of 2000KMS. run in any month will be paid additionally, by the Bank @ Rs.12.00/- per KM. basis.

23. Maximum limit of monthly car hiring charges acceptable to the Bank is Rs.30000.00 (Rupees Thirty thousand only).

24. The car will move in the state of West Bengal, preferably in Kolkata, Howrah, Hooghly, Purba Bardhaman, Paschim Bardhaman, Birbhum, and other districts as per the requirement of Bank officials.

25. Total numbers of cars to be hired 1(One).

Specifications of Car to be hired on monthly basis: Commercial New A.C. car (A.C. Maruti, Swift

Dzire/Hyundai Xcent ,Maruti WagonR, Maruti Swift, Maruti Celerio, Tata Tiago, Tata Zest and

Hyundai Grand I10 car or any of CC900) not more than 5 years old.

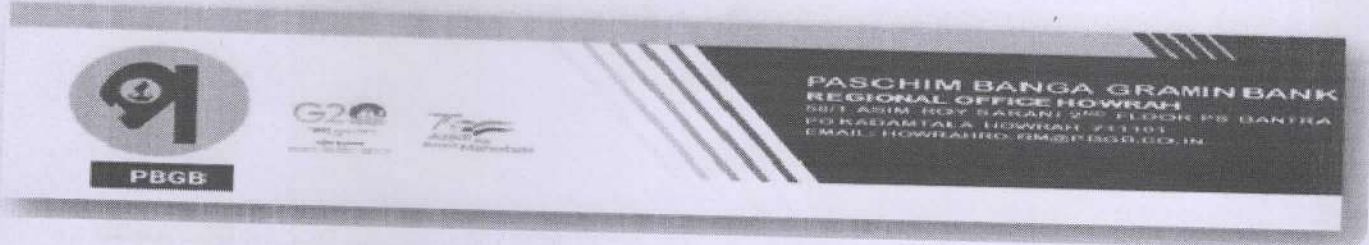

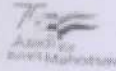
